### the Irish in Britain

As a national agency we bring together Irish clubs and societies, supporters, individuals, artists, social care providers, businesses and networks in multiple forums to work together to support and celebrate our vibrant community.

Our core membership remains the primary focus of our networking opportunities and we continue to be driven by their creativity and energy to engage. As we expand our reach and engagement across different segments of the community we look forward to new opportunities to bring people together to enhance the connections and experiences of all Irish people in Britain.

#### **OUR IMPACT THIS YEAR**

More than 450 individuals and organisations attended our events this year with:

- Member organisations providing social care services within the community meeting to share innovation and information on contracting and commissioning, social enterprise and quality standards.
- Clubs continuing to work together to secure added value through bulk purchasing.
- Artists supporting communites to take a new approach to engaging younger or older people with memory loss or bridge communities through joint projects.
- Business networks coming together to support community initiatives such as Cuimhne (pronounced qu'eevna) our memory loss and dementia campaign.

In a recent survey amongst members, supporters and partners, growth and expansion of the membership came out as an agreed priority for our future and for the well-being of the community and this will shape much of our work over the coming two years.

Working with communities of interest, organisations and groups as well as individuals, our work can be a way to generate a collective community response to the new and emerging needs within the community.

## Building the **SUSTAINAE**

of Irish organisations

Our member's innovation and dedication to providing the best possible services for their local Irish community continues to inspire us.

In 2012-13 we delivered over 400 interventions with Irish organisations. Our support



ranged from information on funding and developing social enterprises to offering one-to-one advice on managing premises, reviewing strategic plans, negotiating with local authorities and signposting members to expert advisors.

#### **OUR IMPACT THIS YEAR**

- Launch of a new website www.irishsurvivorsinbritain.org to support Survivors of Institutional Abuse living in Britain. We also assisted individuals to establish and sustain selfhelp groups.
- 17 community organisations participated in a year-long learning programme on how to develop new services and consider new business models for sustainability.
- 65 lunch club volunteers accessed basic training to build confidence and knowledge

about how to support older Irish people who develop memory loss.

We supported members in Glasgow, Birmingham and **London** to develop partnership projects with arts and cultural organisations to improve engagement with their local Irish community.

#### As a result of our work:

- 96 organisations citied they had increased confidence and skills to develop their services in different ways
- 27 member organisations actively reduced risk to their organsiation
- 31 felt their management had demonstrably improved
- 47 felt better informed about key areas of their work.

## **CAMPAIGNING**

### for the Irish in Britain

Ours is a dynamic and active community and campaigning to raise awareness about relevant issues is a vital part of our work.

#### CUIMHNE - PRONOUNCED 'QU'EEVNA' / IRISH FOR MEMORY



The Cuimhne initiative focuses on our aim to become the first memory loss friendly minority ethnic community in England and Wales. We have seen the

confidence of Irish organisations to provide services for those with memory loss grow significantly; celebrated best practice among our members such as Irish Community Services Happy Days Café in Greenwich; and worked in partnership with corporate organisations keen to support the initiative.

#### **IRELAND INSPIRES**

Ireland Inspires focused on innovative ways to celebrate our cultural contribution. We supported the cultural talent of both our professional artists and makers as well as our wider



community through unique events and activities. Culture Night was a nationwide celebration of arts and music, while our youth music project worked in ways that not only celebrated our rich heritage but developed new and creative ways to showcase it.

#### **DIASPORA VOICE**



A key focus this year has been to inform, engage and create dialogue amongst the Irish in Britain in the

year-long review of the Irish Constitution. We have run listening events in London, Birmingham, Leeds and Manchester and encouraged individuals and members from across the community to make submissions to the Convention on issues from samesex marriage to extending the voting franchise to Irish citizens living overseas.

## UNDERSTANDING the Irish community

All our work is underpinned by evidence and a thorough understanding of the continuing and emerging needs of our community. We are a central resource for our members and the wider community seeking information about the Irish community in Britain.


#### **OUR IMPACT THIS YEAR**

 We published our Research Bibliography which draws together over 300 entries of research published since 2000. It covers a myriad of subject areas - from culture to elders, Travellers to patterns of migration. It also includes more contemporary information sources such as podcasts and visual archives.

 In partnership with member organisations and academic institutions we researched and reported

on the changing needs of the Irish in Britain, 'Fresh Perspectives: The needs of the Irish in London' and 'The Cost of Change: A Report into the Impact of the Welfare Reforms on the Irish Community in London' were both produced in partnership with the London Irish Centre. They outline the most contemporary and pressing issues for the community and can be drawn on by our members and local authorities to evidence the need for targeted services.

We advocated for and secured inclusion about the Irish experience and needs in commissioned research by the All Party Parliamentary Group on Dementia. The research reported on the shared concerns of Irish and other ethnic communities about appropriate care and support for elders with dementia.

### the Irish in Britain

Our continued representation has led to greater recognition and inclusion of the Irish community in key policy areas as well as encouraging Irish citizens in Britain to remain engaged with public life back home. This year our focus has been on dementia, health service commissioning and political representation.

#### **OUR IMPACT THIS YEAR**

#### **Cuimhne – Irish Memory Loss Alliance**

- The All Party Parliamentary Group on Dementia recognised Irish issues as a result of our contribution to their investigation on lack of access to services by older Irish people and their carers (Ethnos 2013).
- Our partnership with the Alzheimer's Society was strengthened and resulted in joint training to community organisations.

#### How Irish Are you?

 The release of the Census 2011 figures highlighted our community has an older age profile in need of focused and appropriate services. Successful representation to the Office of National Statistics has resulted in us securing the health data we require to support our members demonstrate the need and their potential reach at a local level.

#### **Joint Strategic Needs Assessment**

 We have continued to press commissioners to include the Irish community in their Joint Strategic Needs Assessments (JSNA), providing them with robust information and facts about their local Irish community and how best to involve and consult with them.

#### All Party Parliamentary Group on the Irish in Britain

 We provide a working secretariat and strategic advice to the All Party Parliamentary Group (APPG) on the Irish in Britain, benefiting from the assistance of parliamentarians across most areas of community interest. We continue to participate in the British Irish Parliamentary Assembly, as the agency best able to represent the Irish in Britain.
